Applications sent via U.S. Mail must be postmarked no later than August 31, 2022.
- Funds will be disbursed on a first come/first serve basis in the form of a check (mailed no later than October 3, 2022 to the mailing address provided) or posted as a credit to your sewer account.
 ***PROPERTY OWNERS:** If your sewer account is delinquent, your rebate if any will be credited to your sewer account.
- **Tenants:** Proof of (a) latest rent payment **AND** (b) rental/lease agreement must be submitted. **TENANT PORTION OF RENT MUST BE AT LEAST \$100.00/MONTH**
- **Property Owners and Tenants:** Proof of residency required (IE: Drivers License/Identification Card and utility bill, etc.)
- **Hotel/Motel/Rooming house/Flexible Stay Apartment residents are NOT eligible for the program**
