## Benefits in Becoming a Patriot Employer

In addition to hiring a high caliber employee, there are also financial benefits in hiring veterans.

### Work Opportunity Tax Credit:

A federal tax credit available to employers who hire individuals from eligible target groups with significant barriers to employment, including veterans.

### The Veterans Opportunity to Work to Hire Heroes Act of 2011:

There are two tax credits associated with this law. They are:

- **The Returning Heroes Tax Credit:**

Provides incentive for businesses to hire unemployed veterans.

- **The Wounded Warrior Tax Credit:**

Doubles the existing tax credit for long term, unemployed veterans and service connected disabilities.

### The Special Employer Incentives Program:

Allows an employer to hire a qualified trainee at an apprenticeship wage. Employers are also reimbursed for up to half the veteran's salary to cover certain supplies and equipment, additional instruction expenses, and any loss of production. Visit:

### Differential Wage Payment Credit:

Allows a credit of up to \$4,000 for employers who pay Reserve and National Guard employees while they are away on Active Duty for more than 30 days and have been employed for more than 90 days.

### Nevada Business Tax Deduction for Hiring Veterans:

Allows an employer to deduct certain veteran employees' wages from the total amount of wages paid by the employer, under certain guidelines.

## What Does it Take to Become a Patriot Employer?

Enroll and complete the Nevada Department of Veterans Services Patriot Employer Program course. The course provides information on where to find qualified veterans, how to recruit them, how to retain them as well as the benefits, including financial benefits, in hiring veterans. The course is FREE and takes an average of two to four hours to complete.

After successful completion of the course, you will receive a certificate suitable for framing from Governor Steve Sisolak. The certificate is presented in a ceremony or in the mail, whichever you choose. Your business will also receive a Patriot Employer decal to prominently and proudly display.

Once certified, you can choose (or not) to receive information on new veterans employment benefits, innovations in veteran hiring and retention.
